An application letter addressing briefly your ability to meet the position competencies set out in the Position Description;</li> <li>2. Most recent curriculum vitae that includes: <ol style="list-style-type: none"> <li>(i) Details of all your current and previous work history, including the following information: <ol style="list-style-type: none"> <li>(a) Position title, employer and the dates you held the position</li> <li>(b) Brief summary of key accountabilities and achievements</li> </ol> </li> <li>(ii) Certified copies of all certificates of academic achievements, qualifications, trainings, professional affiliation and other documents provided in support of your application. (<i>Certified copies are those that are seen and verified by an Officer of the Court as true copies of the originals</i>); and</li> <li>(iii) Your contact details for correspondence purposes in relation to your application for this position.</li> </ol> </li> <li>3. Three (3) Referees</li> <li>4. Completed and signed Authorization Form</li> </ol>
